Dear Parent or Guardian:

Students who are not residents of Bath County may be admitted to Bath County Public Schools when it is educationally beneficial to both the school division and the students. All non-resident students are required to apply for admission on an annual basis.

The enclosed application form(s) is to be completed and returned to your child's appropriate school by Monday, July 11, 2011 to be processed for your child's enrollment at Millboro Elementary School, Valley Elementary School, or Bath County High School. All tuition fees are due with the application(s). (Tuition fees are listed on the application.) Non-resident students may be admitted on a space-available basis after a review of school records and upon the recommendation of school principals and the division superintendent. Non-resident students are required to comply with all division and school policies, regulations, and rules, including attendance, and make satisfactory academic progress. By action of the School Board, non-resident student absences may not exceed five (5) per semester. Please remember that the School Board retains the right to alter policies as needed, including tuition rates.

Non-resident applications will be reviewed by the School Board for approval/disapproval at the August 2, 2011 School Board meeting. The School Board will not accept non-resident applications after August 1, 2011 for the 2011-12 school year. A student's non-resident application and tuition fee not received prior to August 1 will not be admitted to Bath County Schools. If an application is not approved, your payment for tuition will be returned to you; however, if a student's application is approved and the tuition fee has been deposited, the tuition will be <u>non-refundable</u>.
