VSBA Early Bird Seminars

Bullying: Legal Authority and Legal Liability

Bullying of students by other students—both in and outside of school—is a topic of great concern. This presentation will focus on two different—and sometimes complementary, but sometimes competing—facets of the issue: (1) the reach of school authority for acts occurring outside of schools (including electronic communications and social media). In that regard, last summer's decision from the U.S. Court of Appeals for the Fourth Circuit, *Kowalski v. Berkeley County Schools*, 652 F. 3d 565 (4th Cir. 2011) is important and instructive; (2) On the other hand, some schools have been found liable for failing to do enough to control student bullying. This presentation will discuss some of these cases as examples.

If You Can't Beat 'Em,.... : Bring Your Own Technology Policies

After years of attempting to ban personal electronic devices (PEDs) from campus, many school divisions are reconsidering, because of the apparent futility of enforcing such policies (more than 75% of 12 to 17 year olds have their own cell phone), because there are positive ways PEDs can be used in an education environment and because integrating technology into the classroom seems necessary to prepare students for future opportunities and to teach responsibility and civility in a digital age. *Can schools devise a reasonable, efficient and practical way to maximize the educational benefits of PEDs while minimizing the negative impacts?* This presentation will highlight legal and practical pros and cons of the various approaches a school division can take regarding PEDs on campus and the legal issues that need to be considered in developing policies regarding PEDs.

Chef Remmi Smith is Sodexo's appointed Student Ambassador for Nutrition and Health, and is host of the popular Internet and TV cooking show, Cook

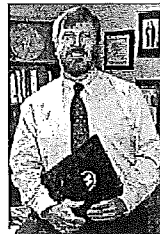
