Building Successful Schools and Students: The State's Role in Funding

The Problem

As Virginia faced the challenge of balancing the budget following the Recession of 2008, policymakers made deep cuts in funding for our schools. In large part these cuts were achieved by weakening the Standards of Quality (SOQ), which define the state and local partnership which supports Virginia's public schools. Eight years after the advent of the recession state funding remains below pre-recessionary levels.

As Governor McAuliffe crafts his first biennial budget, it is estimated that budget writers will have additional General Fund (GF) revenue over the next 4 years to spend above the official revenue forecast for the current 2014-16 biennium.

It is time to reinvest in the education of Virginia's children to ensure that they all have access to an educational opportunity of high quality.

The Context

Funding of public education is a shared responsibility. Local school boards work in partnership with the General Assembly, Board of Education and local appropriating bodies to provide public education in the Commonwealth. Recent changes to the state funding for public education widened the already significant gaps between the actual costs of services at the local level and the state's reimbursement for the provision of those services.

Neglect of the Standards of Quality predates the recession, with the last meaningful additions to the Standards coming over a decade ago. As the SOQ's have been neglected, the Standards of Accreditation and Standards of Learning have been made substantially more rigorous, adding new graduation requirements and consistently raising the bar for school accreditation. Beyond the Standards, the General Assembly has added costly mandates each and every year, regardless of state funding.

Key Funding Priorities

- · Provide targeted funding for:
 - Improving the teacher/pupil ratio for programs and services for students with limited English proficiency
 - Educational technology infrastructure in the SOQ
 - · Bridging resource gaps for challenged schools
 - Investing in high-quality professional development for teachers and administrators
 - Competitive compensation to attract and retain high-quality staff
 - · Reducing class-size and provide flexibility in staffing ratios
- Continue efforts to shore up state VRS funding
- Utilize lottery funds to support school construction and supplementing state SOQ funding rather than supplanting general fund support
- Renew the use of local prevailing practice to help determine state funding for support positions






