KidWind National Championship New Orleans

We made it down to New Orleans to participate in the National Championships. Our students did us proud. While we did not bring home any trophies, I heard nothing but good about our students from everyone I talked to. Our designs impressed a lot of people. Other teams came by our table to look at our turbines and ask questions. We teamed up with University of Wisconsin Madison students to compete against other teams in an instant challenge and finished third out of 12 teams comprised of two college students and two high school students. We helped a middle school team that was having difficulties. The American Wind Energy Association convention is the largest of its type in the world. We have been invited to show our work at the AWEA Virginia Forum at JMU on June 22nd. Our students got to meet many from the industry and explore future career paths with these people. Because of the generosity of the BCPS community we were able to raise all of the funds that we needed for this trip. As coaches, Mr. Altizer, Mr. Grubbs, and Mr. Ozols feel that this will likely be a life changing experience for some of the students. More than that, it shows the rest of the country what Bath County schools and students are capable of. We brought home a lot of ideas from the college teams- the next higher level of competition- and are looking forwards to incorporating those ideas in our next iteration of wind turbines. There will be a KidWind competition at DSLCC next spring, in part because of all the hard work that our students have put into their turbines the past two years. Moving from Virginia Tech to Virginia Beach and now to our local area is a huge plus for us.
