The students will only miss 2 days of school due to the pupil holidays on Feb. 23 & 24. Our band has already been accepted to perform in Disneyworld! The last time we traveled to Disneyworld, our band performed in a parade for an estimated 1.2million people!! I am coordinating the trip myself, which will save the band thousands of dollars.
