I just wanted to give you a written update on some of the conversations and resulting information that took place at the GRASP reception that took place on Nov. 1st at the Stonewall Jackson Hotel in Staunton. The reception was for the counselors, principals, superintendents, donors and other guests affiliated with the Staunton, Augusta, and Waynesboro schools to celebrate the wonderful work that GRASP is doing to help students and their families make post-secondary education a reality. Although, I, as a Bath County Advisor don't fall into that category, Bettsy Heggie, GRASP CEO, specifically requested that I attend. I was beyond honored.

In attendance were some of the major political supporters of our program, GRASP founder, Senator Walter Stosch, Senator Emmett Hanger Jr., Delegate Stephen Landes and Delegate Richard "Dickie" Bell. I was fortunate enough to have some face time with all of them to thank them for their contributions to the program and give them a little insight into how their program has helped our students as well as the general direction our students are taking in regards to post secondary education. With the tuition rates of 4 year universities ever increasing, many of Bath County students who would ordinarily choose a 4 year university are instead choosing the 2+2 program. The attend community college for 2 years with a transfer agreement to the 4 year university of their choice.

I expressed this trend to Senator Stosch who is a big supporter of this path for higher education. He told me that he will be working on getting some more monetary incentives to Bath County to support these students and their families on the 2+2 path.

I also expressed to everyone I spoke with that I'm extremely fortunate to work with a counseling department that embraces GRASP as well as all of the other college access programs. Not all advisors are so lucky. So on that note, I wanted to tell you how very grateful I am. I'll be sure to keep you updated as more information comes my way.
