SUBJECT: SUPERINTENDENT’S REPORT - PRESENTATIONS

SOL Accountability Reports Update – Mrs. Hicklin

BACKGROUND: A preliminary timetable was announced in June for the release of student achievement on 2016-2017 state assessments, 2017-2018 state accreditation ratings and federal Priority and Focus school designations, as well as 2017 graduating cohort reports – including graduation and dropout rates – to school divisions and the public.

Bath County High School and Millboro Elementary School, based on three or more consecutive years of Full Accreditation, have been identified as Fully Accredited for Three Years based on 2016 General Assembly legislation.

Federal Pass Rate data became available to divisions on July 24 and will be released publicly on August 15.

State accreditation ratings will be released to the news media and general public on September 13. The news release will include federal Priority and Focus school designations.

As communicated to school divisions via Superintendent's Memo No. 220-16, September 2, 2016, under legislation passed by the 2016 General Assembly, schools that have been fully accredited for three consecutive years will be fully accredited for three more years. At the end of the three year period, the Board shall review the status of the school for each individual year within the three-year period. If the school would have been accredited each year within the three-year period, the school will be fully accredited for three more years. The specific language change to the Standards of Quality is provided below.

§ 22.1-253.13:3. Standard 3. Accreditation, other standards, assessments, and releases from state regulations.

A....The Board shall review annually the accreditation status of all schools in the Commonwealth. The Board shall review the accreditation status of a school once every three years if the school has been fully accredited for three consecutive years. Upon such triennial review, the Board shall review the accreditation status of the school for each individual year within that triennial review period. If the Board finds that the school would have been accredited every year of that triennial review period the Board shall accredit the school for another three years. The Board may review the accreditation status of any other school once every two years or once every three years, provided that any school that receives a multiyear accreditation status other than full accreditation shall be covered by a Board-approved multiyear corrective action plan for the duration of the period of accreditation. Such multiyear corrective action plan shall include annual written progress updates to the Board. A multiyear accreditation status shall not relieve any school or division of annual reporting requirements.

As noted in Superintendent's Memo No. 220-16, September 2, 2016, this legislation went into effect on July 1, 2016, with the accreditation ratings for 2016-2017. Based on this legislation, schools that were fully accredited in 2013-2014, 2014-2015, and 2015-2016 will be fully accredited for 2016-2017, 2017-2018, and 2018-2019. Data for these schools will be examined in the summer of 2019 and if the schools met the accreditation requirements for each of the three individual years, they will be fully accredited for three more years. Similarly, additional schools that were fully accredited in 2014-2015, 2015-2016, and 2016-2017 will be fully accredited in 2017-2018, 2018-2019 and 2019-2020. Data for these schools will be re-examined in the summer of 2020 for the 2020-2021 accreditation ratings.

A list of schools that will be fully accredited for three years under this legislation is attached. Those schools that will be fully accredited for 2016-2017, 2017-2018, and 2018-2019 based on being fully accredited in 2013-2014, 2014-2015, and 2015-2016 have an "X" in the column labeled **Fully Accredited 2016-2017 through 2018-2019**. Schools that will be fully accredited for 2017-2018,

2018-2019 and 2019-2020 based on being fully accredited in 2014-2015, 2015-2016, and 2016-2017 have an "X" in the column labeled **Fully Accredited 2017-2018 through 2019-2020**.
